Recess was called at 5:30 pm to 5:49 pm. Daggett Fire Department needs these grants to grow with up to date and better equipment. If a grant needs immediate approval for submittal because of the application deadline, information of grant will go to office and an immediate call for a vote will be set forth. Chief Clemmons does not apply for grants that have any cost or matching funds required.

- 1. SCE Grant: is applied by under Daggett Firefighter's Association; no CSD approval needed.
